The Sales Agreement provided for the offer and sale, from time to time, of up to \$75,000,000 in the aggregate of our common shares, no par value per share, in an "at the market offering" as defined in Rule 415(a)(4) promulgated under the Securities Act of 1933, as amended, or the Securities Act. As of the date of this prospectus supplement, we have terminated the Sales Agreement and the offer and sale of shares under the Sales Agreement prospectus supplement.

Prior to termination, we sold 70,002 of our common shares pursuant to the Sales Agreement for net proceeds of approximately \$86,000.
